- 2. Terry Kraus, GTA Treasurer/Membership, provided an update on membership numbers and year end financial standing of the GTA. Although no active recruiting was done since March 2020, the GTA has 125 active members and a positive financial record for the year 2020.
- 3. John Updike, 2020 GTA Vista West Building Representative, interviewed Anthony Carungay, General Manager of the Gateway. John asked him questions that were emailed in prior to the meeting. Anthony kindly elaborated on Greystar team members and their responsibilities (he offered to distribute a summary to all residents by mid February); gave an update on the fire in Vista East (November 2020); plus assured the continuing effort to educate residents about recycling.
